TYPE 12 ENCLOSURES

Application:

Designed to enclose electrical, electronic controls, instruments and components and provide protection from falling dirt, dust, oil and water.

Construction:

- Steel fabricated doors and enclosure.
- Smooth, continuously welded seams without knockouts, cutouts, or holes.
- Welded brackets provided for enclosure mounting.
- Continuous hinged door is removable by pulling hinge pin.
- Door is secured with NEMA style clamps.
- Provisions for padlocking.
- Door is sealed with closed cell, oil resistant gasket.
- Print pocket is provided.
- Collar studs are provided for mounting optional inner panels.
- Grounding studs are provided.

Finish:

- ANSI 61 gray powder coating inside and out over phosphatized surfaces. Optional panels are powder coated white.

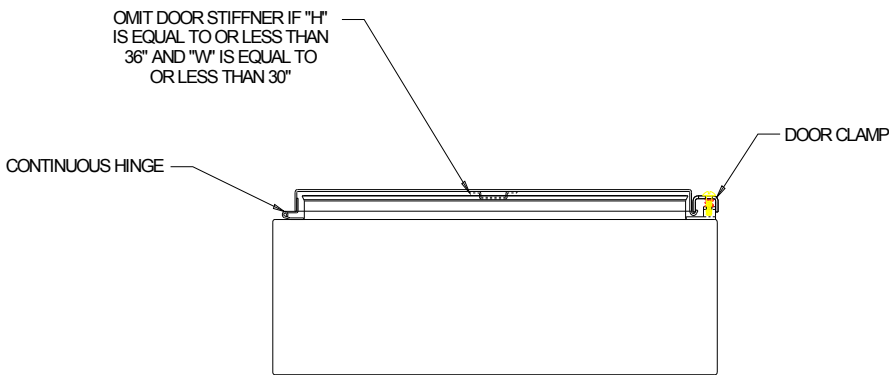
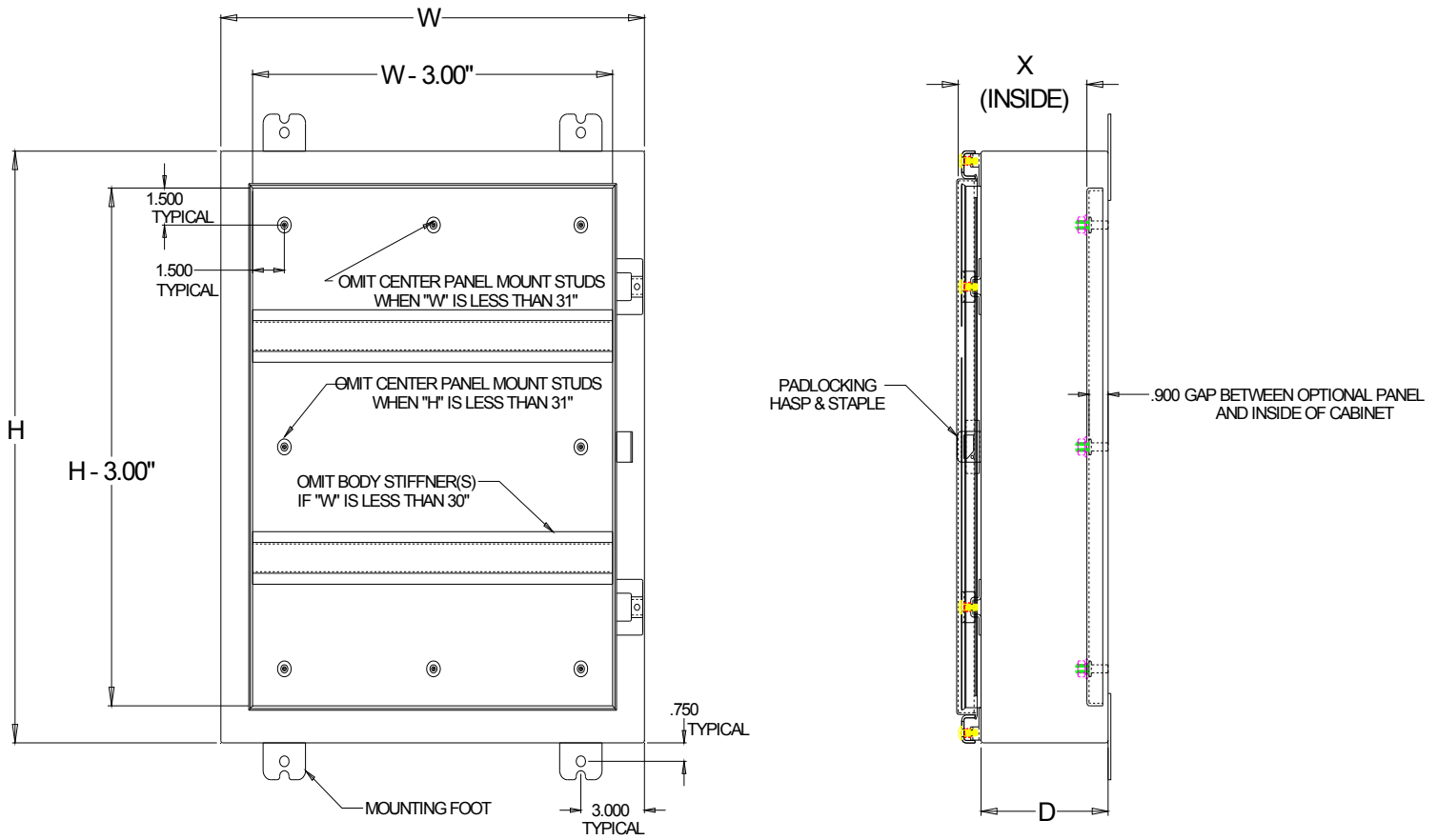
